Insilco Limited (“**Company**”), a listed public company, has initiated its voluntary liquidation with effect from June 25, 2021 as per the provisions of the Insolvency & Bankruptcy Code, 2016 (“**Code**”) read with the Insolvency and Bankruptcy Board of India (Voluntary Liquidation Process) Regulations, 2017 (“**VL Regulations**”). I have been appointed as the Liquidator of the Company with effect from 28 November 2022 in place of the erstwhile liquidator of the Company, Mr. Chandra Prakash.

The initiation of the voluntary liquidation process of the Company and my appointment as the Liquidator is pursuant to the requisite resolutions passed by the shareholders and creditors of the Company in accordance with the provisions of the Code.

The Company is under voluntary liquidation with effect from June 25, 2021 in accordance with Regulations 3(3) of the VL Regulations and I am exercising the powers of the liquidator as provided for under the provisions of the Code read with the VL Regulations, and any other laws as may be applicable for the time being in force in order to effectively liquidate the Company.

A Public Announcement was published on June 30, 2021 by the Erstwhile Liquidator calling upon stakeholders to submit their claims. The Public Announcement was done in accordance with Regulation 14 of the VL regulations, as per which the last date of submission of claims was July 25, 2021 (i.e. 30 days of the Liquidation Commencement Date).

The communications for initiation of Voluntary Liquidation, the appointment of the Liquidator and the consequent public announcement calling upon the stakeholders to submit their claims was also sent to the existing employees of the Company, creditors appearing in the record of the Company and various statutory and licensing authorities engaged with the Company. The said intimation has also been duly shared with the Registrar of Companies and the Insolvency & Bankruptcy Board of India. The intimation has also been uploaded on the website of the Company as well as the Bombay Stock Exchange. Further, a notice intimating the commencement of Voluntary Liquidation dated July 14, 2021 has also been issued to the Income Tax Department under Section 178(1) of the Income Tax Act, 1961.

Pursuant to the public announcement, claims have been received from various stakeholders which have been verified and accordingly, on the basis of proofs of claims in accordance with Regulation 30 of the VL Regulations, the below stated List of Stakeholders has been prepared.
